Against the background of the concept of Freedom of Contract, this lecture explains how contracts come into existence and identifies their essential content and ancillary provisions. Key concepts: capacity; offer and acceptance; express and implied terms; warranties; collateral contracts.

LECTURE 2: THURSDAY, 18 MARCH 2021 FROM 17:00 TO 18:30 (GMT+6) ► VARIATION (INCLUDING WAIVERS AND ESTOPPEL BY CONVENTION), ASSIGNMENT, NOVATION, CONTRACTUAL TERMINATION

Overview:

Lecture 2 is concerned with how concluded contracts can be intentionally varied and terminated. Key concepts: waiver; estoppel by convention; assignment; novation; termination.

LECTURE 3: THURSDAY, 25 MARCH 2021 FROM 17:00 TO 18:30 (GMT+6) PERFORMANCE; NON-PERFORMANCE; FRUSTRATION (INCLUDING FORCE MAJEURE AND IMPOSSIBILITY)

Overview:

Lecture 3 is concerned with the performance and non-performance of contracts. Key Concepts: impossibility; frustration.

LECTURE 4: THURSDAY, 1 APRIL 2021 FROM 17:00 TO 18:30 (GMT+6) ► BREACH, ANTICIPATORY BREACH, REPUDIATION, DAMAGES (LIQUIDATED DAMAGES, COMMON LAW DAMAGES), SPECIFIC PERFORMANCE, MITIGATION OF DAMAGES

Lecture 4 is concerned with the breach of contracts and the consequences of their breach. Key concepts: breach; anticipatory breach; repudiation; specific performance; damages; mitigation.
